ORDER:

The unnatural death of Miss Rishiteswari, 1st year B.Arch student of Acharya Nagarjuna University has been reported to be on account of harassment and stress. In this regard Government is concerned over deplorable behaviour in students, and in this context, there is immediate necessity to arrest tendencies like indiscipline, ragging, absenteeism, intrusion of outsiders and anti social elements.

2. Accordingly, Government hereby order to implement the following measures:

- i) Erection of CCTV cameras in all the Universities
- ii) Enrolment of attendance through biometric
- iii) Release of reimbursement and scholarships based on biometric attendance.
- iv) Ensuring no entry to outsiders into campuses.

3. All measures above must be complied by 31st August, 2015. The Vice-Chancellors of all Universities in Andhra Pradesh State are advised to adhere to the above instructions and implement scrupulously.

Major recommendations of the committee (constituted by the Supreme Court of India) headed by Sri R.K. Raghavan (Former Director, CBI) on prevention of ragging in Educational Institutions:

- 1) Each student taking admission in a college must furnish signed annual undertaking at the beginning of every academic year stating that he is aware of the relevant instructions/ regulations against ragging as well as punishments that may follow acts of ragging. ✓
- 2) Each institution must compulsorily incorporate in its admission prospectus about the definition of ragging and the directives issued by the government various courts to prevent to stop ragging and the punishment that are prescribed for an offence of ragging so has to sensitize to the students and the parent in this regard. ✓
- 3) Meaningful advertisement and campaign should be undertaking by the State Government and Educational Institution through the various news papers and electronic media, posters, handouts etc. drawing attention to the concerned about the ban in respect of ragging and publicizing its potential evils. Apart from the above educational institutions may hold multi-pronged campaigns through Audio visual aids, counseling sessions, workshops, poster making competitions etc. to bring home the message about ragging has been social evil.
- 4) 'Freshers Day' in educational institution should be held within a fortnight from the beginning of the academic sessions. ✓
- 5) Educational Institutions may engage professional counselors for seeking assistance at the time of admissions to council freshers and seniors and emphasize the importance of developing Camaraderie.
- 6) The anti ragging committee and squad should be activated, especially at the beginning of the academic session. ✓
- 7) It is mandatory for the institution, where the incident of ragging is reported, to file a First Information Report (F.I.R.) before the local Police authorities such reports should also be made to the Civil Authorities and Higher Police authorities for taking necessary action in the matter.
- 8) Hostel Wardens must be issued mobile phones by instructions and the detail of the telephone numbers widely circulated amongst students. Similarly action should be taken in respect of every important functionary such as Heads of institutions, faculty members of Anti ragging committee District and Sub-Divisional authorities, District and Sub-Divisional Civil and Police authorities, local police stations etc. ✓

The Government of Andhra Pradesh has initiated several steps to transform Andhra Pradesh State into a Knowledge Society and Education Hub of global standing.


2. The State has made significant progress in this regard. However, certain stray incidents of ragging have come to light, despite strict guidelines / instructions issued from time to time by the Government. Against this backdrop, it is felt necessary to reiterate the main aspects of the Anti-Ragging Policy of Government, to be read with circular instructions, circulars and GOs already issued in the matter, for guidance of all concerned, as follows:

A] Ragging is prohibited within or outside any educational institution.

B] whoever teases or embarrasses or humiliates a student shall be punished with imprisonment for a term which may extend to six months or with fine which may extend to one thousand rupees or with both (or) assaults or uses criminal force to or criminally intimidates a student shall be punished with punishment for a term which may extend to one year or with fine which may extend to two thousand rupees or with both [or] wrongfully restrains or wrongfully confines or causes hurt go a student shall be punished with imprisonment for a term which may extend to two years or with fine which may extend to five thousand rupees or with both [or] causes grievous hurt to or kidnaps or abducts or rapes or commits unnatural offence with a student shall be punished with imprisonment for a term which may extend five years and with fine which may extend to ten thousand rupees (or) causes death or abets suicide shall be punished with imprisonment for life or with imprisonment for a term which may extend to ten years and with fine which may extend to fifty thousand rupees.

C] It is the responsibility of the Head / Manager of educational Institution, upon receiving any complaint on ragging, to inquire into or cause an inquiry to be made forthwith and take such action as deemed necessary and he shall be punished in case of negligence.

D] A Review Committee will be constituted by the District Collector as Chairperson and other members will be Superintendent of Police as Vice Chairperson; Revenue Divisional Officer, Sub Divisional Police Officer, College Principal as members. The Committee shall meet twice before the academic session and twice during academic session. Apart from this, the educational

institutions should provide for the constitution of a Committee consisting of parents and guardians of the students.

E] Every Institution shall constitute a Committee to be known as **Anti Ragging Committee** to be nominated and headed by the Head of the Institution, and consisting of representatives of Civil Society & Police; Local media; Non Govt. organizations; Faculty members; Parents & students.

F] Every Institution shall constitute a smaller body to be known as the Anti Ragging Squad to be nominated by the HOD.

G] Every institution shall constitute a body to be known as Monitoring Cell on Ragging and coordinate with the affiliated colleges under domain of the University.

H] No outsiders other than inmates of the hostels shall stay in the hostels and no outsiders shall stay on campus, whatsoever.

I] The entry into hostels and mess shall be by biometric identity only.

J] The hostel corridors shall have CC-TV cameras fixed.

K] The biometric data and video footage shall be monitored by third party arrangement to avoid tampering.

L] A periodical inspection and cross verification of data shall be verified by the administrative staff.

M] Disciplinary Committees may be constituted at Hostel level, which should be vigilant by conducting several inspections particularly during vulnerable times and at vulnerable places. There shall be student representatives in the committee. The mischievous elements shall be identified and mischievous actions shall be liable for punishment as per the rulebook of the University / College / Institution.


N] A quarterly review of disciplinary measures and facilities with regard to hostels shall be undertaken by the Vice Chancellor / Principal concerned and a status report has to be sent to the Andhra Pradesh State Council for Higher Education / Commissioner of Collegiate Education / Commissioner of Technical Education, who shall send consolidated report to Government.

O] Notice Boards be erected in all conspicuous places of Higher Education Institution and display Anti Ragging Provisions and Penalties as per A.P. Prohibition of Ragging Act, 1997 both in Telugu and English. Details of Anti Ragging Committee with phone numbers be displayed in all conspicuous places of the institution.

P] Faculty must be sensitized on the provisions of the Act as well as on the panel consequences.

Q] Seminars, workshops, lectures by police, district and legal authorities be conducted to sensitize the students.

R] It is the responsibility of the Vice Chancellors / HODS of other Educational Institutions to ensure a safe campus / college life conducive to welfare and development of students.

S] All the vice Chancellors/Registrars/Principals are advised to ensure appointment of warden, Dy. Warden, Resident Matron to all the hostels ensuring proper management. The regular employees available in the University/college shall be posted to the post of Warden and Deputy Warden.

T] The Heads of Institutions may also take up publicity in local media and programmers to build awareness among the senior students as to what acts tantamount to ragging and how violation of provisions has implication for them from their career point of view.



COLLEGE CONDUCT RULES FOR STUDENTS :-

1. The college will be run by the Management with the Principal being the Head of the Institution.
2. The Management or Principal may take any appropriate action as deemed fit in exigencies to protect or maintain general discipline, prestige and standards of the Institution and all such decisions are final and binding on the students.
3. Students of the College are not permitted to resort to strikes and demonstrations. Participation in any such activity shall automatically result in dismissal from the college.
4. No Student Unions except professional associations are permitted in the College.
5. Any student responsible for bringing outsiders into the college campus for settling student disputes will be expelled from the college.
6. Smoking, consumption of alcohol drinks, drugs, playing cards, gambling of any kind is prohibited in the College premises.
7. No student shall leave the classroom without the permission of the teacher.
8. Calling students out of their class rooms while the lecture is in progress is prohibited.
9. Students must attend college in time.
10. Student should not sit on the parapet walls or on the steps or on the staircases. They are forbidden from loitering in the verandahs or in the campus at any time during the session of the college.
11. In case of cancellation of a class, students shall go to the Library, but not to be found anywhere else in the campus.
12. Hall tickets will be issued for University Annual Examinations only after the students clear all the dues including dues to the Hostel & Library.
13. Any student found to be violating the rules of conduct and discipline will be dealt with severely including expulsion from college. Their misbehavior will also be reflected in the conduct certificate issued at the time of leaving the college.
14. No one should indulge in ragging or eve-teasing in any form. In case of non compliance, the act attracts serious punishment and entails summary dismissal also.
15. All candidates who secure admission in this College are deemed to have agreed to all the rules and regulations and such other rules and regulations added, deleted or amended from time to time. If any clarification or doubt arises in respect of the above rules and regulations, it shall be for the Management to issue the clarification and it is final.
16. **Cell phones are banned in the Campus. Violation of this rule entails severe punishment.**

The Hon'ble Supreme Court, the University Grants Commission and the Government of A.P. have evolved guidelines/Regulations on curbing the menace of Ragging in Higher Educational Institutions. The same were circulated to all the Universities so as to take stringent action on the ragging incidents and take all precautionary steps to curb Ragging in Educational Institutions.

The Vice-Chancellors are requested to direct all colleges under the university jurisdiction to take all precautionary measures for prohibition of ragging in the Colleges and also outside the colleges especially in hostels and give wide publicity through Print and Electronic Media, Pamphlets, Banners, Notices etc. on the Guidelines / Regulations. Further, it is requested to conduct meetings with the senior students and people from the Academic Institutions, Judiciary, Police Department etc., on the Act provisions and guidelines of the Hon'ble Supreme Court and the UGC on the issues of ragging.

Further, the Hon'ble Supreme Court upheld the recommendations of the Committee headed by Dr.R.K.Raghavan for taking corrective measures to curb the menace of the ragging in the Educational Institutions:

The same were circulated to all the Universities so as to take stringent action on the ragging incidents and take all precautionary steps to curb Ragging in Educational Institutions.

The Vice-Chancellors were requested to take corrective measures on the lines recommended by Dr. K. Raghavan Committee. A copy of the letter addressed to the Vice-Chancellors is enclosed herewith for ready reference.

The Inspector of Police of respective circles of the Educational Institutions may be requested to convene the meetings with the Higher Educational Institutions and Senior Students with a view to motivate the provisions of the Act on Prohibition of Ragging and criminal punishments on the incidents of ragging etc. Further, it is requested to depute the police personnel in the surrounding places of the Educational Institutions from the commencement of 1st year classes of all courses.

In this background, the Director General of Police is requested to issue necessary instructions to the Commissioner of Police / Superintendent of Police of all Districts in Andhra Pradesh for providing necessary support to the Educational Institutions in curbing the menace of ragging in the Educational Institutions as per the guidelines of the Hon'ble Supreme Court, Regulations of the UGC, State Act Provisions etc., to see to it that 2017-18 would be a ragging-free academic year.

- ◆ Ragging invokes Suspension / Dismissal from the College / Imprisonment

✗ Assaulting or using criminal force or criminal intimidation	☑ Imprisonment upto 1 year + fine upto Rs. 2,000/-
✗ Wrongfully restraining or confining or causing hurt	☑ Imprisonment up to 2 years + fine upto Rs. 5,000/-
✗ Causing grievous hurt, kidnapping or rape or committing unnatural offence	☑ Imprisonment upto 5 years + fine up to Rs. 10,000/-

The committee headed by Dr.R.K.Raghavan has made recommendations to curb the menace of ragging in the educational institutions - i.e. Anti Ragging Cells - Anti Ragging Committees - Anti Ragging Squad - Monitoring Committee of Anti Ragging - Help Desk - Emergency Call Unit - CCTV Cameras at vital points - Alarm bells - Media Campaigning - Prominent publicity inside and outside through Boards at vital points - Action against the defaulting institutions - Information Booklets for students/ parents/ staff covering ragging - in- discipline issues - Prospectus covering anti ragging and undertaking from the students/ parents /guardians - First aid kit - Anti Ragging Help line - Anti Ragging Message - Anti Ragging Website - Anti Ragging Van - Emergency Call Unit - Quick response teams - Sudden and surprise checks.

Wherever negligence on the part of the establishment is noticed, severe action on such erring officials will be taken according to the provisions of law.

Whoever notices any instance of ragging, the fact has to be brought to the notice of concerned University / College authorities like Warden, Registrar or Vice-Chancellor or to the nearest Police Station.


